**Ingredients:** sugar, glucose syrup, acidity regulator: citric acid; aromas, colours: E133, E171.

**Colour:** characteristic of the additive.

**Taste and smell:** characteristic of the additive.

Mechanical impurities: impermissible.

#### **Detailed requirements-hard candy:**

The physicochemical parameters: content of water- not more than 3.5%

dry matter content - not less than 96.5% the ash content of soluble in HCl - to 0.1%

Storage temperature - max+ 25 ° C

Harmful metals content: cadmium <0,010 mg/kg,

lead<0,050mg/kg
